### **Board Member Job Description**

1. Regularly attend board meetings and important related meetings.
2. Volunteer for assignments and complete in a timely manner.
3. Stay informed about committee matters, prepare for meetings, review and comment on minutes and reports, and get to know other Board members (build a collegial working relationship that contributes to consensus).
4. Participates in fund raising for the organization.
5. Active participant in the board's annual evaluation and planning efforts
